2009 Coastal Cup Race Entry Agreement and Release of Liability

In consideration of Encinal Yacht Club's acceptance of my entry, I agree as follows:

1. My yacht will be equipped to conform to any USCG, US SAILING, NOR required ISAF and/or Class/Fleet safety requirements.
2. I agree to be bound by the Racing Rules of Sailing and by all other rules that govern this event as adopted by the US SAILING, the NOR's, sailing instructions and amendments governing the race.
3. I own or have chartered the yacht entered and I am a member of a yacht club or sailing association that belongs to US SAILING.
4. I acknowledge that there are risks inherent in the sport of yacht racing.
5. The undersigned hereby assumes all responsibility for any and all risks including personal injury, or death, to myself or my crew, property damage, including, but not limited to, the failure or breakage of my yacht or equipment of my crew and my yacht, arising out of, or related to, my participation in the race and/or weather conditions during the race.
6. We all, skipper and crew alike, waive to the fullest extent permitted, any and all claim we may have against Encinal Yacht Club, their members, officers, directors, committees and/or employees because of such participation in the Coastal Cup.
7. The undersigned further expressly agrees that the foregoing Release and Waiver Agreement is intended to be as broad and inclusive as is permitted by the law of the State of California and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

The undersigned have read and voluntarily sign the release agreement, and further agree that no oral representations, statements or inducement apart from the foregoing written agreement have been made.
